It reviews experiences in sub-Saharan Africa related to the following issues: "Investments in inputs that are most cost-effective"; "Curriculum reforms to enhance relevance"; "Changes in instructional strategies and teacher development to improve school effectiveness"; and "Differentiation of programs and diversification of providers to improve equity of results". It explores how the emphasis on quality and equity affect the way education systems are financed and managed, and how student's learning progress is measured and monitored. Résumé : Le présent ouvrage est issu d'un dossier préparé dans le cadre de la contribution de la France à la 36e session de la Commission de la population et du développement de l'ONU, tenue en mars-avril 2003 sur le thème « Population, éducation et développement ». Alors qu'à la suite de la Conférence de Jomtien, en 1990, la priorité est d'abord à l'accroissement (le plus rapidement possible) des niveaux de scolarisation, et que l'éducation (scolaire) est présentée dans les discours officiels comme « la » solution aux « problèmes » de population et de développement, il apparaît utile et opportun de s'interroger à nouveau sur ce triptyque « population, éducation et développement », notamment sur les conditions de réalisation de l'Education Pour Tous (EPT), et sur les finalités de l'éducation. Sans prétendre à une quelconque exhaustivité sur une thématique aussi complexe, cet ouvrage en aborde divers aspects, certains encore peu traités, combinant exercices de synthèse et réflexions critiques. En regard de la situation actuelle, des enjeux et défis qui se posent en Afrique subsaharienne, il concerne prioritairement cette région du monde.

Une première partie aborde ce triptyque à travers l'influence de l'éducation sur la fécondité et la mortalité, la problématique du défi posé par la fuite des cerveaux, et l'apport de la recherche en économie sur la relation entre éducation et développement. Intitulée « les politiques éducatives en question ». la deuxième partie propose tout d'abord une réflexion sur la nouvelle donne pour l'éducation au Sud dans le contexte de la mondialisation, suivie d'un développement sur la question du coût et du financement de l'éducation, avec en dernier lieu une interrogation : quelles politiques éducatives pour quelle éducation ? La troisième partie porte sur les rapports entre école et société à travers, d'une part, une analyse de l'évolution des représentations et des rapports entre famille et école, et, d'autre part, un état des connaissances sur les relations entre scolarisation et travail des enfants. La dernière partie traite enfin de deux thématiques spécifiques : l'impact du Sida sur l'éducation ; les relations entre éducation, violences et conflits. L'ouvrage se termine par une série d'enseignements et de recommandations, aussi bien sur le plan de la recherche que des politiques liées à l'éducation.

Introduction : Cet ouvrage synthétise les développements et conclusions de plusieurs études qui ont été menées sur le triptyque « Démographie, Paix et Sécurité » (DPS), sous l'égide du bureau régional pour l'Afrique de l'Ouest et Centrale du Fonds des Nations Unies pour la Population. Ces études empiriques font l'objet, dans le présent ouvrage, d'un effort de capitalisation de l'état des lieux et du diagnostic des perspectives de développement à long terme, sous la forme de scénarios, pour le Sahel. Élaboré dans un contexte où le nexus DPS interpelle nombre d'agences de coopération bilatérales et multilatérales ainsi que le Système des NU, cet ouvrage se veut, à travers le diagnostic stratégique du Sahel qu'il propose, une contribution à l'analyse des composantes de cette problématique et à la compréhension des enjeux qui lui sont associés, en ayant à l'esprit l'axiome selon lequel il ne saurait y avoir de bonnes réponses à une question mal posée et qu'à l'inverse une question bien posée est à moitié résolue. À ce premier objectif, qui est de l'ordre de la clarification conceptuelle et analytique, s'ajoute un second qui est d'ordre plus opérationnel : l'ouvrage se veut une contribution à l'amélioration de la Stratégie Sahel du Système des NU dont le triple objectif est (i) d'améliorer la gouvernance inclusive et efficace dans la région ; (ii) de renforcer les mécanismes de sécurité nationaux et régionaux afin qu'ils puissent faire face aux menaces transfrontalières de plus en plus pesantes et (iii) d'intégrer les plans et les interventions humanitaires et de développement pour renforcer la résilience à long terme. Cet ouvrage est, en somme, une contribution intellectuelle à la compréhension du nexus DPS pour la définition d'un cadre conceptuel en vue de guider les efforts de construction de la résilience dans le Sahel central. Cet effort s'inscrit dans une perspective opérationnelle, dans le sens d'affiner et de mieux orienter les politiques mises en œuvre pour un Sahel résilient. Outre qu'elle est à la fois théorique et empirique, cette réflexion se veut systémique en ce qu'elle éclaire tout autant les différentes variables constitutives du système que les interrelations entre elles. L'ouvrage comporte, outre cette introduction, quatre parties et une conclusion. La première partie est consacrée au contexte, à la définition des concepts, à la problématique et à la méthodologie suivie. La seconde partie porte sur les regards croisés du nexus DPS dans le Sahel central. La troisième partie élabore et présente les scénarii d'évolution possibles pour la région. Enfin, la quatrième partie présente la stratégie d'opérationnalisation du scénario de référence.

Summary : In 2000, Zimbabwe's century old land movement took a swift turn, rupturing into nationwide occupation of mainly White owned commercial farms. The speed with which occupations spread, their organisation, the political and economic context, the historical origins and interaction of the forces, shaped an unprecedented and complex land movement impacting on the region, the continent and beyond. Zimbabwe's land occupations were unique in two ways. First, the leading role of War Veterans of the 1970s anti-colonial guerrilla war in the land occupations was exceptional. Second, the simultaneous challenge to racial, settler economic dominance and neo-colonialism by marginalised peasants, farm workers, war veterans, urban youth and the unemployed, was a new experience in post-colonial history of Africa's liberation movements. Zimbabwe's land occupations were a long continuum of land struggles to resolve the colonial legacy of racial resource distribution but as they occurred, the role played by the state, the contested terrain of the civil society, formidable political opposition and imperialist interventions of western powers clouded the identity of the land movement thereby making it difficult to distinguish the moving current and the identity of forces from the wider political conflicts swirling around it. Who exactly initiated the occupations and for what reasons? This thesis attempts to unpack these intricately locked forces in a bid to understand their origins, interests, strategies, tactics and above all, the alliances between and amongst them, for clearer understanding of the core of the movement. This thesis traces the history of Zimbabwe's liberation movement as foundation to understanding political reconfigurations that shaped post independence social movements and assesses agrarian technology responses to such a dramatic social change of Africa's post-colonial settler society. The thesis provokes prognostic thoughts about the role played by social capital of liberation struggles in future economic and cultural emancipation from shackles of neo-colonialism and racial, settler capitalism.
